Report Context

This report uses enrollment data pulled from the Colorado Department of Education, population data compiled from the American Community Survey and U.S. Census Bureau, birth rates from the Colorado Environmental Public Health Tracking Program, and enrollment projections compiled by Douglas County School District.

General Information about Douglas County


Douglas County School District (DCSD) is located in Douglas County, in the Denver metropolitan region of the state. DCSD schools are located in Castle Pines, Castle Rock, Centennial, Englewood, Franktown, Highlands Ranch, Larkspur, Littleton, Lone Tree, Parker, and Sedalia. The map below shows the geographic boundaries of DCSD (outlined in red).

Map of DCSD and Surrounding School Districts

Douglas County School District covers 870 square miles south of Denver and north of Colorado Springs.

Douglas County School District is in Douglas County. Surrounding districts include Jefferson County (in Jefferson County), Littleton (in Arapahoe County), Cherry Creek (in Arapahoe County), Elizabeth (in Elbert County), Elbert (in Elbert County), Lewis-Palmer (in El Paso County), and Woodland Park (in Teller County).

There are a total of 94 schools* within DCSD boundaries, including one school authorized by the Colorado Charter School Institute (CSI), twenty charter schools authorized by DCSD, and three Alternative Education Campuses (AECs). **Appendix A** has the full list of school choices in DCSD.

*In Colorado, the number of schools is calculated according to the number of school codes associated with each contract. School codes are assigned, upon requests of the authorizer, as a school begins operating.



Population Characteristics


School Aged Children

The below information captures the number and percent of school aged children in Douglas County. The most recent data available is from the American Community Survey (ACS), which is collected and released by the U.S. Census Bureau. This dataset was released in 2017 and includes summarized responses from 2011, 2012, 2013, 2014, 2015, and 2016 for Douglas County. The U.S. Census Bureau releases their results every ten years. 2017 ACS: Children in Douglas County




The table above lists the results for school aged children from the last two censuses (from the year 2000 and the year 2010) and the results from the American Community Survey in 2017. While the overall population of school aged children in Douglas County has increased since 2000, over the past decade, trends have been flat. The largest increase in population for Douglas County is the high school age range (15 to 19 years old), from 10,291 children in 2000 to 23,642 children in 2017 (130%). When viewing results from the 2010 census to the 2017 ACS, changes in population size are much less substantial. The largest increase is still in the 15 to 19 year old age range (25% increase). Children under 9 years of age had decreases in population, the largest decrease is for under 5 years of age (10% decrease). As shown in the pie chart above, the 2017 ACS found that, of the school aged children in Douglas County, the largest percentage (28%) are 10 to 14 years of age. 27% are 5 to 9 years of age, 24% are 15 to 19 years of age, and 20% under 5 years of age.

Birth Trends

Live births are captured by the Colorado Environmental Public Health Tracking Program for Douglas County. When viewing this cumulative data over the past 20 years, the number of births rose steadily from 1997 until 2006, with a peak of 4,210 births. Since then, the number of babies born each year has remained flat. The most recent birth data shows 3,426 births in 2017 (a percent decrease of 19% since 2006). Below is a chart of live birth data for this region.








Demographics

Using 2017 U.S. Census Bureau data, Douglas County ranks as the wealthiest county in Colorado for median household income at \$111,154, \$45,000 higher than the statewide median household income.

School demographic data from the most recent October Count shows that DCSD serves lower percentages of students eligible for free or reduced price lunch, minority students, special education students, and English Learners than the state average. DCSD schools serve more gifted students and more students with a 504 plan than the state.

Enrollment

Total Student Enrollment over Time

The number of students attending DCSD has increased by 1% over the past five years (from 66,702 students in 2014-15 to 67,591 students in 2018-19), indicating a flat enrollment trend. Last year, enrollment for DCSD decreased slightly, the first time in five years enrollment has not continually increased. For Colorado Early Colleges – Douglas County (CEC-DC), authorized by CSI in Douglas County, student enrollment has increased 86% over the past five years. CEC-DC opened in 2014-15.

Adjacent school districts to Douglas County overall have seen flat enrollment increases over the past five years (0.2%, from 234,097 students in 2014-15 to 235,364 students in 2018-19). South of Douglas County, adjacent district Lewis-Palmer in El Paso County saw the largest increase in enrollment since 2014-15 (11%, from 6,207 students to 6,895 students). The second largest enrollment increase was for a small rural district, Elbert, to the southeast of Douglas County and adjacent to Lewis-Palmer, with a 10% increase in enrollment. Cherry Creek, north of Douglas County and adjacent to Denver Public Schools, is the only other surrounding district with increases in enrollment. However, Cherry Creek's enrollment change is relatively flat, with a 2% difference over the past five years. All other surrounding districts have seen decreases in their enrollment over the past five years. Total enrollment values can be seen in the table below.

Enrollment by Grade Level over Time

Student enrollment for DCSD schools has increased overall and at the middle and high school levels.

The largest increase in student enrollment is for 9th through 12th grades, with an almost 9% increase. The only level with a decrease in student enrollment is for elementary grades Pre-Kindergarten through 5th, with a 3% decrease over the past five years. Middle school grade levels have seen a 1% increase over the past five years, and a 1% decrease in the past three years, indicating that enrollment changes are flat.

For Colorado Early Colleges – Douglas County (CEC-DC), the only school currently authorized by CSI in Douglas County, school enrollment has increased.

This data represents the only school authorized by CSI in DCSD, Colorado Early Colleges - Douglas County.

Student enrollment for CEC-DC in DCSD increased by 86% over the past five years. Since 2016-2017, over a three year period, CEC-DC has seen a 25% increase.




Choice Into and Out of DCSD

DCSD Choice

The number of students who live in Douglas County and choice out of DCSD has increased from 2,084 students in 2014-15 to 2,878 in 2018-19, a choice out increase of 38% (these values include those students choicing into schools authorized by CSI). The number of students who live outside of Douglas County and choice into DCSD has increased from 3,989 students in 2014-15 to 4,397 students in 2018-19, a choice in increase of 10%. The below chart lists all Douglas County residents choicing out of DCSD (dark red) and non-Douglas County residents choicing into DCSD (light red) for the past five years.


DCSD Choice In and Choice Out by Number of PK-12 Students



Choice Into Schools Authorized by CSI

The number of students who live in Douglas County and choice into schools authorized by CSI has increased from 236 students in 2014-15 to 386 students in 2018-19, a choice in increase of 64%. The number of students who live outside of Douglas County and choice into schools authorized by CSI has also increased from 89 students in 2014-15 to 218 students in 2018-19, a choice in increase of 145%. The below chart lists all students choicing into schools authorized by CSI in Douglas County by Douglas County residents (dark blue) and non-Douglas County residents (light blue) for the past five years.



Pie Chart of Non-Douglas County Residents Choicing Into CSI (N=218)


The largest percent of non-Douglas County residents attending schools authorized by CSI in Douglas County come from Cherry Creek (38%). Cherry Creek is located in Arapahoe County and is adjacent to DCSD. APS is directly adjacent to Cherry Creek, north of DCSD, and accounts for 5% of students. Elbert is a rural district adjacent to DCSD in Elbert County and accounts for 12% of this population.

A total of 31% of non-Douglas County residents choicing into CSI come from non-adjacent school districts, including 6% from DPS.

Choice Out of DCSD and CSI

The previous page showed how a growing number of Douglas County residents are choicing out of DCSD and, at the same time, a growing number of Douglas County residents are choicing into schools authorized by CSI in Douglas County. The chart below shows the population of Douglas County residents that choose to attend neither DCSD schools nor schools authorized by CSI in Douglas County.





The values above show a 35% increase over the past five years of Douglas County residents choosing schools outside of the district in which they live, an increase from 1,848 students in 2014-15 to 2,492 students in 2018-19.



Choice Districts

The largest percentage of Douglas County residents attending schools outside of Douglas County geographic boundaries are attending Littleton, Cherry Creek, or Jefferson County schools consistently each year. The next largest percentages were both Lewis-Palmer and Elizabeth school districts.

All but three DCSD charter schools have an elementary school, all but two have a middle school, and five have a high school. As a whole, charter schools authorized by DCSD have seen a 37% increase in enrollment since 2014-15. Hope Online Elementary and Middle Schools, the lowest performing charter schools in Douglas County, have seen the largest enrollment declines over the past five years. Otherwise, all eighteen other charter schools are rated Performance, the highest rating given by the state. Under the CSI rating system, twelve would be Distinction, given to schools scoring in the top 25% of schools in the state. Seven of the twenty charter schools have a Core Knowledge or Classical school model. Three have STEAM models and one has a STEM model.

Listed below is the only school authorized by CSI in Douglas County.

Colorado Early Colleges – Douglas County (CEC-DC) serves 9th through 12th graders and is located in Parker. In 2019, CEC-DC scored in the top 5% of schools in the state and earned the highest rating available to CSI schools, Performance with Distinction. Enrollment for CEC-DC has increased by 86% since the school opened in 2014-15, and 25% over the past three years.

CEC-DC has an early college model. In Colorado, there are twenty schools with an official Early College designation from the Colorado Department of Education, not including two schools recently authorized by the Colorado Charter School Institute (CSI), Colorado Early Colleges – Windsor and Colorado Early Colleges – Fort Collins West. CSI authorizes seven early college schools in total. The other fifteen early colleges are authorized by Denver Public Schools, Eagle County, Falcon 49, Greeley, Lake County, Mapleton, and Pueblo 60. The closest early college to CEC-DC is Southwest Early College, in Denver.

Home-Based Education

The number of students enrolled in full time home based education has increased over the past five years. Over a 1-year period from 2017-18 to 2018-19, home-based education enrollment increased by 142% (from 375 students to 913 students).

Out of all DCSD enrollment, 1.4% of students use home based education.

Population Estimates

Douglas County School District Enrollment Projections

Enrollment projections for Douglas County were compiled from DCSD's Master Capital Plan for 2019-2020¹. In this report, DCSD projects a district-wide decrease of 170 students or an approximate .26% decrease from last year for 2019-20. The largest projected decline is for middle school enrollment (153 students), followed by elementary school enrollment (10 students) and high school enrollment (7 students).

Enrollment projections for charter schools differ from district-wide trends. While DCSD projects enrollment decreases of 772 students for neighborhood schools, charter school enrollment is projected to increase by 602 students. This enrollment increase is largely attributed to Ascent Classical Academy (opened in 2018-19), Global Village Academy (opened in 2015-16), Leman Classical Academy (opened in 2018-19), Parker Performing Arts (opened in 2016-17), Renaissance Secondary School (opened in 2017-18), and World Compass Academy (opened in 2015-16). All six of these charter schools opened within the last four years. As shown on the table on page 9, seven charter schools in DCSD have flat or declining enrollment over the past five years.



Below is a map that contains all schools located in Douglas County. Number 21 (Colorado Early Colleges – Douglas County) is the only CSI School. DCSD charter schools are numbers 1 (Academy Charter School), 3 (American Academy), 5 (Ascent Classical Academy), 6 (Aspen View Academy), 8 (Ben Franklin Academy), 14 (Challenge to Excellence), 27 (DCS Montessori), 38 (Global Village Academy – Douglas County), 43, 44, & 45 (Hope Online Elementary, Middle, and High), 50 (Leman Classical Academy), 58 (North Star Academy), 61 (Parker Core Knowledge Charter School), 62 (Parker Performing Arts), 66 (Platte River Charter Academy), 72 (Renaissance Secondary School), 84 (Skyview Academy), 87 (STEM School Highlands Ranch), and 94 (World Compass Academy). **Appendix A** has a full list of school names, along with their corresponding map number.





Most schools in DCSD are rated as the top two performance ratings for academics. Only six schools did not receive the highest state rating of performance, Hope Online Elementary and Middle Schools (#43 & #45), Legacy Point Elementary (#48), Northeast Elementary (#59), Sierra Middle (#83), and South Ridge Elementary (#86). Hope Online – Elementary (#43), a charter school, received the lowest rating in the district, Priority Improvement. All but one (South Ridge Elementary) saw decreasing enrollment over the past five years.

Because schools are high performing by state rating in this district, this map uses calculated percentiles for each school based on their total percent of points earned on the School Performance Framework. To do this, each school's total percent of points earned on the achievement, growth, and postsecondary workforce readiness sections of the School Performance Framework were compared to all of the other schools across the state. Each school then received a percentile based on their performance. Schools above CSI's "Performance with Distinction" rating threshold (75th percentile) received a distinction rating, coded as blue. Performance is coded as green, improvement as yellow, priority improvement as orange, and no value as grey. To see all percentile values, view **Appendix A**. 57% of schools in DCSD would be considered Performance with Distinction under CSI's rating system, placing them in the top 25% of schools in Colorado.






Map of Schools with a Decrease in Enrollment

The map below contains all the schools in Douglas County, any schools that decreased their enrollment size from 2014-15 to 2018-19 are marked as "Y" on the map (color coded as purple) Schools with increasing enrollment are marked as "N" (color coded as brown). Nearly 65% of schools have decreasing enrollment over the past five years in Douglas County.

Also included in the DCSD Master Capital Plan 2019-2020 report is a list of overutilized and underutilized neighborhood schools, noted below on the "Map of Schools with a Decrease in Enrollment" as "Overutilized", "Underutilized" or "Closely Monitor". Overutilized refers to any school with 50 or less projected seats available. Underutilized schools are those utilizing less than 65% of their facility capacity. Closely monitored schools are those utilizing over 95% of their facility capacity. This metric is available for traditional neighborhood schools only and includes a three to five year outlook for traditional school enrollment for the district.

Of the sixteen schools listed as "underutilized", fourteen have seen decreasing enrollment over the past five years. Nine of the sixteen are elementary schools, five are middle schools, and two are high schools. Six of these schools are located in Highlands Ranch, six are in Parker, two are in Castle Rock, one is in Littleton, and one is in Castle Pines. Two of the sixteen schools have Improvement Plan ratings, seven have Performance Plan ratings, and six would be considered Distinction under CSI's rating system.
