# CSI Board Approves New School Application for Wildflower Montessori Public Schools of Colorado in Grand Junction

Denver, CO (June 13, 2023) – During its June 13 regular board meeting, the Colorado Charter School Institute (CSI) Board of Directors approved the new charter public school application for Wildflower Montessori Public School of Colorado (WMPSC) in Grand Junction. In November 2022, the CSI Board <u>approved</u> WMPSC in Aurora.

## Wildflower Montessori Public Schools of Colorado Opening in Grand Junction

WMPSC utilizes a "micro-school" Montessori model, which emphasizes a "diverse network of community-embedded schools". The mission of WMPSC *is to provide families with child-centered, authentic Montessori education that bridges academic outcomes and social-emotional development through intimate learning communities deeply rooted in place, equity, and belonging.* 

The first Grand Valley micro-school sites are expected to open in the 2024-25 school year. The sites will initially serve students in grades PK-3 and build out over time to serve PK-6 with four total microsites across the Grand Valley over five years—ultimately serving 192 students. Each school site will be teacher-led, designed in partnership with families and community partners, and no larger than two classrooms (32-60 students total).

"I'm so grateful for all the support we have already received from the community here in the Grand Valley," said Emma Reicks, one of the founding Teacher Leaders at WMPSC in Grand Valley. Reicks is an experienced educator, trained Montessorian and long-time resident of Grand Junction.

"An authentic Montessori education helps students develop their intrinsic motivation for learning as well as the social and emotional skills needed to thrive in life," said WMPSC Board Chair Latia Henderson. "Research shows that spending even a few years in a Montessori environment has a long-term impact on student well-being and achievement."

"At WMPSC, we help advance the mission of local school districts to provide all students with a high-quality education. Our schools also support communities by making more free Early Childhood Education spots available for families facing childcare and financial obstacles," said Henderson.

WMPSC is currently accepting interest forms from families who may want to enroll their children. Families and community members who would like to learn more or support WMPSC's

### **CSI Application Process**

The local district released WMPSC to apply to CSI in December of 2022. WMPSC submitted its application for Grand Valley to CSI in March.

The CSI new school application review process includes a comprehensive analysis of the written proposal, a capacity interview with the school's proposed leadership, board, and founding team, and a presentation to the CSI Board's Performance Management Committee. The review team included members of CSI staff with expertise in finance, governance, academics, and operations as well as external reviewers. The process also requires a community meeting to hear from local stakeholders.

Once a contract is executed between the school's board and the CSI Board of Directors, the school's team will participate in the Year 0 process with CSI staff—a process developed to monitor and support new schools as they prepare for opening.
